- c. S. Giles stated that the Fiber people placed a box on the pole on Campbell Rd route 94 end and it is obstructing sight. He also feels it is too low, and the plow wing might hit it. L. Keefe will look at the location and follow up with Fidium if needed.
- d. S. Giles asked about paying the contractor for the Campbell project. L. Keefe said that she has been updating Cliff and had spoken with him on 10/22 to advise the State confirmed that payment would be sent this week.
- e. K. Speed said that Exeter accepted the Exeter end of his drive. He has divided his property into lots to fit the Exeter ordinance. He is bringing this back to the Garland Select Board to ask them to accept the driveway on the Garland side as a road. R. Fick provided background on this issue. We stopped plowing the Speed's driveway two years ago as it is not on our inventory as a road and is not on the State Inventory either. L.
